

Minutes of the Grant County Fiscal Court May 15, 2017

The Grant County Fiscal Court met in Regular Session on Monday, May 15, 2017

7:00 P. M. in the Grant County Courthouse in Williamstown, Kentucky.

Those in attendance were: Magistrate Bobby Newman, presiding, Magistrate Jacquelyn Riley, and Magistrate Shawna Coldiron. Joe Taylor, Grant County Attorney, and Deputy/Judge and Fiscal Court Clerk, Pat Conrad were also present. Judge/Executive Stephen Wood was out of town and absent.

Guests present were: Joshua Bradford with Marathon Oil Company, John Souder, Kim Crupper, Sheriff Chuck Dills, David Rose, Steve Tatum, and Cheynne Miller with the Grant County News.

Bobby Newman the 3rd District Magistrate called the meeting to order.

Magistrate Newman recognized Mr. Chris Ammerman with the Grant County Extension Service so that he could present his budget for the 2017-2018 Fiscal Year. Mr.

Ammerman gave a detailed itemization of his budget line items and asked that the court file his budget as required by the Department of Local Government in Frankfort. The magistrates thanked Mr. Ammerman for bringing his budget and the work that he does in the extension office.

Magistrate Newman presented for a motion the approval of the May 1, 2017 minutes, and of the May 8, 2017 Special Meeting minutes.

Magistrate Riley moved to approve the minutes of May 8th 2017 Special meeting but to table approval of the May 1, 2017 minutes until she could meet with Mrs. Conrad and make changes to those minutes.

Magistrate Coldiron seconded the motion. Magistrate Newman directed the Fiscal Court

clerk to call the roll, whereupon all members present voted in the affirmative.

Magistrate Newman then proceeded to open the bids that were submitted for the materials and supplies for the Grant County Road Department for Fiscal Year 2017-2018.

There were (2) companies that bid for Liquid Asphalt:

Hudson Materials Company bid for Chip Seal Oil (RS-2) per gallon at \$2.20. Enviro High Performance Cold Mix at \$3.60 per Gallon, and Pug Mill @ .30 per gallon for Mixing Cold Mix.

Marathon Petroleum Company bid RS-2 at \$1.66 per Gallon and MC-30 or MC-70 at \$2.61 per Gallon.

Hilltop Stone: This bid stated that the hauling rate for this year will be \$5.50 per ton with an additional \$1.00 charges for hauling Class III Channel Lining.

The following bids were received for salt for snow removal.

Cargill Deicing Technology: \$72.98 per Ton, estimated purchase 1,500 Tons.

Morton Salt: \$89.62 per Ton with a 25 ton minimum dump truck delivery.

Kim Crupper: \$72.90 per ton with next day delivery.

Detroit Salt: \$79.43 per Ton with a maximum of 1,000 tons.

Mrs. Conrad will take those bids and put them in a tabulation sheet for review and action at the next Fiscal Court meeting on May 22, 2017.

Magistrate Newman stated that there was not a citizens address listed on the agenda, but asked if anyone in the audience wished to address the court. Mr. John Souder asked about the county's ability to store salt. Mr. Steve Tatum, county road supervisor stated that we have about 200 ton in stock with room to store 1,200 tons. He went on to say that because of the mild winter we had some left over. Mr. Crupper praised the Road Dept. and stated that they do a good job with conserving the salt and they are frugal and don't overspend.

Mr. Souder then asked about the E911 surcharge and there was some discussion

regarding funding going forward. Mr. Souder stated that he was in favor of adding a surcharge to the electric bills and felt that was a fair and equitable way to fund E911. Joe Taylor, County Attorney, stated that the electric company's position was that they did not feel like they should have to collect a tax on behalf of the county and that his personal opinion was that they would fight having to collect it. He stated that he feels a caucus meeting would be in order so that the court could decide how they wanted to go forward in financing the E911 system.

ADJOURNMENT

Magistrate Bobby Newman then asked for a motion to adjourn until the next meeting of this body on Monday, May 22, 2017 at 7:00 in the second floor courtroom of the Courthouse on Monday, May 1st 2017 at 7:00 P.M. or until the call of the chair. Magistrate Riley made the motion to adjourn and Magistrate Coldiron seconded that motion. All members present voted to adjourn.
