The Grant County Fiscal Court met in Regular Session on Monday, April 16, 2018, at 7:00 P.M. at the Grant County Courthouse in Williamstown, Kentucky. Those in attendance were The Honorable Judge/Executive Stephen Wood presiding, Magistrate Shawna Coldiron, and Magistrate Bobby Newman, and Magistrate Jacqalynn Riley. Deputy Judge Pat Conrad, and Joe Taylor, Grant County Attorney were also present.

The following guests were in attendance: Amanda Kelly with the Grant County News,
David Rose, Steve Tatum, Supervisor for the Grant County Road Department, John
Souder, Chuck Dills, Grant County Sheriff, Jay Johnson, Dianne Mincarelli, Mark Fox,
Martin Riggs, Regional Homeland Security Coordinator, and Debby Lucas Angel.

CALL TO ORDER:

Judge/Executive Stephen Wood called the meeting to order and Mark Fox, Pastor of Cowtown Cowboy Church offered the invocation. Judge/Executive Stephen Wood then led in the pledge of allegiance.

Judge/Executive Stephen Wood gave the citizens in the audience the opportunity to address the court.

Ana Rivera from the Grant County Detention Center stated that she found where the court did approve a purchase of a backhoe for the road department. She stated that their was an organizational chart submitted by the jailer dated September 2016, but it was never adopted by the court. She read an excerpt from the county personnel policy regarding personnel and stated that there are several long-term employees at the Grant County Detention Center that she feels are not being recognized as long term employees.

Mr. David Rose then addressed the court and stated that for the record he as in favor of Grant County reimbursing the City of Dry Ridge for ambulance runs outside of the city limits. He referenced the article that was in the Grant County News last week which indicated that the City of Dry Ridge would be billing the county for those ambulance runs and stated that he had a handout for each of the Fiscal Court members. Mr. Rose stated that he understands that the county does everything by the Fiscal Year.

Dianne Mincarelli addressed the court and asked if the court would consider putting the EMS services question on the ballot. Magistrate Riley stated that while she feels that the court has a moral obligation to provide ambulance services but is not certain how the other members of the Court wish to proceed.

Grant County attorney, Joe Taylor stated that his office has worked hard on getting a better RFP and some of those suggestions had come from the City of Dry Ridge and he appreciated those suggestions. Joe stated that there is no legal obligation for the county to pay for that service.

Mark Riggs, the Regional Homeland Security Coordinator from the Kentucky Office of Homeland Security addressed the court and stated that the Ky. Office of Homeland Security feels that the office needs to better communicate with the counties they serve. They are implementing a "Hometown Safe Initiative" and will be sharing opportunities for grants. He stated that there is money available for law enforcement and security. He stated that there is 4.2 million available for the 120 Kentucky counties. He gets a lot of top secret information and stated that they need to connect the dots, and need to know what the county's biggest concerns and problems are. Magistrate Riley encouraged him to contact Les Whalen, the Grant County Emergency Management Director. She stated

that she feels this community could be a target because of the Ark being located here.

Judge/Executive Stephen Wood called for a motion to approve the minutes of the April 2,

Judge/Executive Stephen Wood presented for a motion for a Second Reading, and approval of Ordinance No. 02-2018-206, relating to Amendment # 1 to the 2017-2018, annual budget, along with the Notice to run in the local paper showing adoption.

Judge/Executive Stephen Wood presented for a motion and approval, a Resolution stating that the Grant County Fiscal Court agrees to allow the Kentucky Transportation Cabinet to replace the county owned bridge, on the South end of Blanchet Road, Grant County, Kentucky, and will accept ownership of the new permanent right of way upon completion of the project. He knows that a lot of people were disappointed last year when we did not have the Bash. Magistrate Coldiron shared that Pendleton County charges \$3.00 per person and Judge Wood stated that was something the court should consider.

Judge/Executive Wood then asked the court if they would like to caucus on Tuesday, April 24, 2018 at 5:30 P.M. It was decided that they will caucus on Tuesday, April 24, 2018 at 5:30 to discuss the ambulance RFP.

Jay Johnson addressed the court and asked if it was a possibility that whoever owns the gas line that is involved with Eagle Tunnel Road would be willing to share in some of the cost to repair that road. Steve Tatum and the Judge will follow up on that possibility. Judge/Executive Stephen Wood reminded the court that there will be a Grant County Public Properties Corporation meeting immediately following this meeting to approve the 2018 Annual Report and to approve payment of the annual filing fee for the Corporation. Judge/Executive reminded the court that the next meeting of this body will be held on Monday, May 7, 2018, or until the call of the chair. The meeting will be held at the Grant
