The Grant County Fiscal Court met in Special Session on Friday, October 30, 2020 at 1:30 P.M. at the Grant County Courthouse in Williamstown, Kentucky. CALL TO ORDER:

A motion was made by Magistrate Riley, and was seconded by Magistrate


