

Grant County Fiscal Court Regular Meeting Minutes February 18, 2025 @ 6:00 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, February 18, 2025, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacqalynn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey, Assistant County Attorney Pete Whaley, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Jenna Johnson. Guest Grant County Sheriff Dennis Switzer, Grant County Clerk Tabatha Clemons, Chris Alstott and Tom Alstott.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the regular meeting minutes of February 04, 2025. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve all claims on the general fund, road fund, and jail fund, along with all transfers presented dated February 18, 2025. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the Grant County Detention Center Contract with County of Gallatin, KY. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve the Amendment of the County Clerk's Budget for 2025, CPI Adjustment as a whole. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to take **no action** in accordance with the provisions of KRS 64.527 to adjust the compensation for 2025 of the members of the Grant County Fiscal Court (Magistrates) in the amount of 2.9% as determined by the Department for Local Government, retroactive to January 1, 2025. All in favor, motion carried.

Motion was made by Judge Dills and seconded by Magistrate Riley to take **no action** in accordance with the provisions of KRS 64.527 to adjust the compensation for 2025 of the members of the Grant County Coroner in the amount of 2.9% as determined by the Department for Local Government, retroactive to January 1, 2025. All in favor, motion carried.

Motion was made by Judge Dills and seconded by Magistrate Coldiron to take **no action** in accordance with the provisions of KRS 64.527 to adjust the compensation for 2025 of the members of the Grant County Attorney in the amount of 2.9% as determined by the Department for Local Government, retroactive to January 1, 2025. All in favor, motion carried.

Judge/Executive Chuck Dills asked the audience if they wished to address the court, and there being none, a motion was made by Magistrate Riley and seconded by Magistrate Coldiron to adjourn.
