Regular Meeting Minutes
June 17, 2025 @ 6:00 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, June 17, 2025, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacqualynn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey, Assistant County Attorney Pete Whaley, and Fiscal Court Clerk Jenna Johnson. Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve the regular meeting minutes of June 03, 2025 and special meeting minutes of June 10, 2025. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve all claims on the general fund, road fund and jail fund, along with all transfers presented dated June 17, 2025. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to appoint Bobby Callahan, Grant County Road Department Laborer, effective on June 23, 2025. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve the Grant County Detention Center Surplus list. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve payment for HB 810 training incentive for Tonya Beagle. All in favor, motion carried.

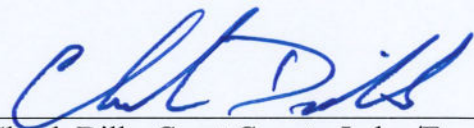
Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to accept the Second Reading on Ordinance No. 0006-2025-0289, Building Fees. All in favor, motion carried.

No motion to approve the salaries for employees of the Grant County Fiscal Court, along with the Road Department, Sheriff's Office and the Detention Center. This was rescheduled for Friday, June 27, 2025 meeting.

Review the Grant County Conservation District Plan of Action for 2025-2026, as well as their Annual Budget. No motion required.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the proposed use of County Road Aid (CRA) and Local Government Economic Assistance (LGEA) Funds for Grant County, KY for Fiscal Year 2025-2026. All in favor, motion carried.
