The Grant County Fiscal Court met in regular session on Tuesday, August 05, 2025, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve the regular meeting minutes of July 15, 2025. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to open Public Hearing regarding the Grant County Tax Rate for Year 2025 – 2026. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve all claims on the general fund, road fund, and jail fund, along with all transfers presented dated August 05, 2025. All in favor, motion carried.

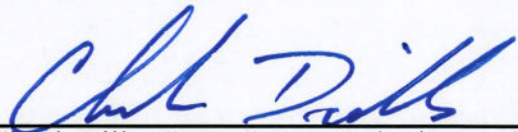
